#### March 25, 2024

Ian O'Sullivan, Dr. Kelly Burks-Copes, and Toni Addison of the U.S. Army Corps of Engineers ("USACE"); Carlos A. Jaramillo, Brad Bergen, and Linda Duncan of the U.S. Coast Guard; David Oliver, Duggan Baker and Jane Miller of Allen Boone Humphries Robinson LLP ("ABHR"); Brian Freedman of the Bay Area Houston Economic Partnership; Jeff Scarborough and Robert Esenwein of Stantec; Jay Luckritz of Black & Veatch; Simon VanDyk and Calep Estes of Touchstone District Services; and other members of the public.

#### ROLL CALL

Ms. Sunstrum called roll and confirmed a quorum was present.

### PUBLIC COMMENTS

There were no public comments.

### COASTAL TEXAS MATTERS

Dr. Burks-Copes discussed ecosystem restoration segment G-28, Bolivar Peninsula and West Bay Gulf Intracoastal Waterway Shoreline and Island Protection ("G-28"), a project included in the Coastal Texas Protection and Restoration Feasibility Study ("Coastal Texas"). She discussed other ecosystem restoration projects underway, including Coastal Erosion Planning and Response Act ("CEPRA") Project No. 1681 to construct rock breakwaters along the Anahuac shoreline of the Gulf Intracoastal Waterway and East Bay.

Mr. Williams also discussed other ecosystem restoration projects. He discussed Project No. 1681 being constructed by Ducks Unlimited, Inc. using grant funding and funds from CEPRA and the Gulf of Mexico Security Act ("GOMESA"). He also discussed a project underway by USACE to reconstruct a rookery island in Galveston Bay near Jamaica Beach.

Lt. Col. O'Sullivan discussed the process for moving projects out of design phase for purposes submitting funding requests for construction. Discussion ensued regarding the possibility of the District, in coordination with GLO, accepting responsibility as the non-federal sponsor for design of G-28 of Coastal Texas, subject to execution of a design agreement with USACE. The Board discussed timing, funding, and estimated costs to complete initial design for the project, as well as a necessary agreement with GLO outlining responsibilities and workflow.

After discussion, Director Combs moved to assume responsibility as the non-federal sponsor for segment G-28 of Coastal Texas. Director Mitchell seconded the motion. The motion was then withdrawn and the item was tabled for consideration later in the meeting.

# CONSIDER EMPLOYMENT MATTERS RELATED TO DISTRICT CHIEF FINANCIAL OFFICER AND DISTRICT COMMUNICATIONS AND PROGRAM MANAGEMENT PERSONNEL

Ms. Sunstrum reported on responses received for the job posting for the District's Chief Financial Officer. She also discussed proposed job postings for a senior project manager and a communications director.

### CONVENE IN EXECUTIVE SESSION PURSUANT TO SECTION 551.071, GOVERNMENT CODE, TO CONSULT WITH ATTORNEYS

At 2:02 p.m., Director Bechtel announced that the Board would convene in executive session pursuant to Section 551.071, Texas Government Code, to discuss legal matters related to acceptance of project responsibility for segment G-28 of Coastal Texas. At 2:22 p.m., Lt. Col. O'Sullivan joined the closed meeting until it ended at 2:27 p.m.

## CONVENE IN EXECUTIVE SESSION PURSUANT TO SECTION 551.074, TEXAS GOVERNMENT CODE, TO DELIBERATE THE APPOINTMENT, EMPLOYMENT, EVALUATION, OR DUTIES OF AN EMPLOYEE

At 2:27 p.m., Director Bechtel announced that the Board would convene in executive session pursuant to Section 551.074, Texas Government Code, to discuss employment matters.

Director Combs moved for the District to assume responsibility as the non-federal sponsor for segment G-28 of Coastal Texas. Director Mitchell seconded the motion, which passed unanimously.
